Communique

1.0 Preamble

The 7th Regular Meeting National Council on Communications and Digital Economy (NCCDE) was held at the Banquet Hall, Government House, Gombe from Monday 2nd - Friday 6th December, 2019. The meeting which had the theme "Leveraging the gains of ICTs in developing and implementing a Digital Economy Strategy for Nigeria". The Meeting was declared open by His Excellency the Executive Governor of Gombe State, ably represented by His Deputy, his Excellency Dr. Manasseh Daniel Jatau, and was presided over by the Honourable Minister of Communications and Digital Economy, Dr. Isa Ali Ibrahim (Pantami), FNCS, FBCS, FIIM who was accompanied by the Permanent Secretary, Mr. M. F. Istifanus.

- 2. In attendance were members of the Council that included Honourable Commissioners and representatives of State Governments, Chief Executives of Agencies and Parastatals in-charge of ICT at the Federal and State levels, NGOs, Members of the Organized Private Sector (OPS) and a host of stakeholders.
- 3. Council received a total of Ninety-Two (92) memoranda out of which Eighty-Six (86) were considered and Six (6) were stepped down. After extensive deliberations, the following Communique was adopted.

(i) Noted:

- a. The change of name and expansion of mandate of the Ministry of Communications to Ministry of Communications & Digital Economy (FMCDE);
- b. The adoption of a policy strategy for the Digital Economy which is anchored on the following eight (8) pillars:
 - i. Developmental Regulation;
 - ii. Digital Literacy and Skills;

- iii. Solid Infrastructure;
- iv. Service Infrastructure;
- v. Digital Services Development & Promotion;
- vi. Soft Infrastructure;
- vii. Digital Society and Emerging Technologies; and
- viii. Indigenous Content Promotion and Adoption.
- c. That e-Government is a critical player and enabler in the sustainable socio-economic growth and development plans of any nation unto a digital economy, as well as fight against corruption;
- d. The importance of technology in the prevention of criminality and other vices;
- e. The need to bring Government services to citizen doorstep in a simple, easy and faster way;
- f. That Lagos State Government is already implementing the Central Billing System and encourage other States yet to start, to follow suite;
- g. The need to recognize the value and promote the use of Shared Services through consolidation of budget planning for ICT;
- h. Lagos State Government is already implementing the integrated land administration and automation solution and therefore encourage other States yet to start, to follow suite; and
- i. the need to put in place, a proper message authentication mechanism to validate requests/responses that are generated through authenticated users.

(ii) Endorsed:

- More funding for ICT to mitigate cyber-attacks, infrastructure and increase awareness in Nigeria;
- ii. That A Committee to be set up to seek start-up funds from Federal Government for Cyber Security & Digital Economy;
- iii. The Creation of an inter-ministerial Committee to formulate a policy to guide the deployment of 5G technology in Nigeria;
- iv. The implementation of e-procurement in Nigeria public procurement processes for the promotion of transparency, cost-effectiveness, competitiveness and value for money;
- v. The development/updating appropriate ICT/Procurement ACT by Bureau of Public Procurement and Ministry of Communications and Digital Economy to ensure mandatory adoption and implementation of e-procurement across government entities (Federal, States & Local Governments);
- vi. That Telecommunication and broadcasting operators should subscribe to Extended Producer Responsibility (EPR) Program;
- vii. That the Telecommunication Operators and importers of broadcast equipment should register with E-waste Produce Responsibility Organization of Nigeria

- (EPRON) as required by the National Environmental (Electrical Electronic Sector) Regulations S.I No. 23 of 2011;
- viii. That FMCDE with the Ministry of Information and Culture (FMIC) and other relevant MDA's should collaborate in the awareness creation on the negative implication of illegal use of Radio Frequently Spectrum;
- ix. Social media platforms which will include Facebook, Twitter be used for engaging, communicating and educating frequent users and stakeholders to leverage digital economy;
- x. The setting up of radio frequency awareness and sensitization unit under the supervision of the Spectrum Management Department for the purpose of regularly informing the public on license procedure/requirements and technical rules guiding the acquisition and usage of radio frequency spectrum;
- xi. The mandatory use of hybrid or multi-brid power solution across all tiers and Agencies of government;
- xii. The creation of an Advisory Board for technology Innovation and Entrepreneurship to drive the implementation of NIIEV with members from academia, Government, investor entrepreneurs and corporate bodies;
- xiii. The review of the Cybercrime Act to incorporate Telecom Infrastructure as Critical National Infrastructure;
- xiv. The escalation of an attractive remuneration for ICT staff in the 3-tiers and agencies of government in the public service to the appropriate authorities by the affected relevant Agencies of Government or professional Bodies;
- xv. That the Memo on "Toolkit For Measuring The Status Of Nigeria On Digital Economy Implementation Based On Selected Indicators For Measuring Digital Economy" should be forwarded to the National Digital Economy Policy Drafting Committee to form part of the National Strategy for Digital Economy;
- xvi. That the Bauchi Bureau for Information and Communications Technology (BICT) should seek for collaboration with NITDA and other relevant Agencies for support;
- xvii. The deployment of Internet of Things (IOT) technology in managing our livestock, they should be tagged and monitored;
- xviii. The acceleration and fast-tracking of activities around the completion of Technology village should be similar to industrial estate/Free Trade Zone models;
 - xix. The recommendation of tax-waiver for start-ups technology companies to Federal Ministry of Finance, Budget and National Planning and NIPC;
 - xx. That NASC's ICT Infrastructure should be upgraded through the support of NITDA to cater for the huge ICT infrastructure required for the expansion of certification system and the sustainability of the NASC's Digital Migration Policy;

- xxi. The establishment of specialized Digital Job Creation Centres by NITDA at the TICs across the Country;
- xxii. The provision of Fiber Optics connectivity by GBB in our Technology Incubation Centres for effective internet connectivity;
- xxiii. That all Primary Healthcare Centres (PHCs) in the country should have access to the internet through the intervention of relevant agencies of government, NIGCOMSAT, Galaxy Backbone, NCC, NITDA and MNOs in the PHCs connectivity project as matter of urgency and as a critical national infrastructure;
- xxiv. A conducive setting that will bring together Computer Scientists/Software Developers to synergize with Language Specialists with the sole aim of developing Algorithms to make our Indigenous Languages computer usable;
- xxv. Full commercialization of the Nigerian Communications Satellite Ltd (NIGCOMSAT) to operate in a more profit-oriented manner;
- xxvi. That the automated settlement scheme should be implemented to encourage further growth of telecommunications infrastructure across the Country pending further amendment by stakeholders;
- xxvii. That National Directorate of Employment (NDE) to partner with NITDA to create ICT hubs nationwide with free internet;
- xxviii. That CBN should collaborate with NITDA to enforce the hosting of data locally rather than taking it abroad;
- xxix. That National Council on Health to use Artificial intelligence in the Health sector and:
- xxx. Support for the Ministry of Science and Technology to seek intervention funds and grants from both local and international donors to establish an ICT skill acquisition centre which will cater for the teeming population of Edo Youths, Micro and medium scale Entrepreneurs in the State. This in no doubt will help to boost the socio-economic well being of the state.

(iii) Urged:

- a. NCC to mandate the bigger Telecom operators to open up their infrastructure for use by other smaller operators;
- b. NCC to review, implement and enforce NCC Open Access Regulation;
- c. State Government to adopt and replicate Federal Government efforts in promoting the Competition in their respective secondary schools to ensure active participation by as many secondary schools as possible across the country;
- d. Council to take a tour of FCT Secondary Education, with a view to ascertaining the viability of the existing Unified School Information Management System, and possible replicate same in other States of the Federation; and

e. Relevant Agencies (NITDA, NCC, NIGCOMSAT, USPF) to support Niger State in the establishment of ICT Hubs.

(iv) Encouraged

- a. The Domestication of GIFMIS and IPPIS platform in all MDAs and States should be encouraged to follow suite
- b. Federal Mortgage Bank to Improve their services to make it more citizen friendly
- Government at all levels to initiate the provision of infrastructure and facilities for Intelligent Transport System.
- d. States MDAs responsible for technology adoption to liaise with Federal Government agencies such as NCC, NITDA, NIGCOMSAT in rolling out the scaling up capacity of the LGA ICT Centres;
- e. The establishment of a strong Project Management Office (PMO) across all State but where PMO is not available, M & E Unit should be domicile across all the State;
- f. The completion of the execution of the Postcode +2 within a time frame.

(v) Advised

- a. All stakeholders of NITDA Academy's open collaboration policy for sustained capacity building to support the achievement of a knowledge society and a thriving national digital economy;
- b. The Ministry of Transportation to embrace the use of ICTs on Nigerian roads;
- c. Digital Bridge Institute to collaborate with other existing institutions and Agencies.
- 4. Council expressed appreciation to His Excellency, the Executive Governor and the good people of Gombe State for hosting the 7th National Council meeting and for the excellent hospitality including the excellent facilities placed at the disposal of participants.
- 5. Council agreed that the 8th National Council on Communications & Digital Economy will be held in Imo State at a later date in 2020 yet to be decided.

Issued this 6th day of December, 2019 Gombe, Gombe State.

2.0 <u>TECHNICAL OFFICIALS/EXPERTS SESSION</u>

The Council meeting was preceded by a 2 day meeting of officials on the $2^{nd} - 3^{rd}$ December, 2019 under the Chairmanship of the Permanent Secretary, Ministry of Communications & Digital Economy Mr. M.F. Istifanus. Present at the meeting of officials were representatives of 17 States of the Federation and the FCT, Heads of

Parastatals & ICT Agencies at both Federal and State levels as well as the Organized Private Sector. The Session also featured Exhibitions. The meeting deliberated on the minutes of the 6th NCC&DE meeting and 46 Matters Arising from the minutes and decisions taken were discussed. 86 out of the 92 memos were considered.

3.0 COMMENCEMENT OF THE COUNCIL MEETING.

3.1 OPENING

The Meeting was declared open by His Excellency the Executive Governor of Gombe State, ably represented by His Excellency Dr. Manasseh Daniel Jatau, his Deputy and was presided over by the Honourable Minister of Communications and Digital Economy, Dr. Isa Ali Ibrahim (Pantami), FNCS, FBCS, FIIM who was accompanied by the Permanent Secretary, Mr. M. F. Istifanus.

- 3.2 In attendance were members of the Council that included Honourable Commissioners from 19 states of the Federation and the Federal Capital Territory (FCT), Chief Executives of Agencies and Parastatals in-charge of ICT in Federal and State levels, NGOs, Members of the Organized Private Sector (OPS) and a host of Stakeholders.
- 3.3 Also present were Directors and representatives of the Federal Ministries and Departments including the Office of the Surveyor General of the Federation (OSGF), National Planning Commission, Federal Road Safety Corps.
- 3.4 Heads of various Federal Parastatals, ICT Directorates/Agencies, Private Sector/Industry representatives, and representatives of Professional Associations e.g Institute of Software Practitioners of Nigeria (ISPON), Association of Licensed Telecommunication Operators of Nigeria (ALTON), Association of Telecommunication Companies of Nigeria (ATCON) and other stakeholders were also in attendance. A list of Delegates is attached to this Report as Annex I.
- 3.5 The Council deliberation was preceded by an official opening ceremony, which commenced with an opening prayer and the National Anthem. This was followed by welcome address by the Hon. Commissioner, Ministry of Science, Technology & Innovation, Gombe State Dr. Aishatu U. Maigari. The Commissioner, while welcoming members informed them of the State Governor's commitment to use ICT for development and improved service delivery. She urged members of National Council on Communication and Digital Economy (NCC&DE) to see the meeting as a clarion call to contribute to the socio-economic development of the country. Finally, she thanked the Governor and Honourable Minister of Communications & Digital Economy for the opportunity given to the state to host the event.

In his remarks, the Hon. Minister of Communications & Digital Economy, officially informed Council Members of change of name from the Ministry of Communications to Ministry of Communications & Digital Economy (MCDE) and expansion of the Ministry's mandate. Consequence upon this, he disclosed eight (8) pillars policy strategy for the successful implementation of Digital Economy in Nigeria, namely:

- i. Developmental Regulation;
- ii. Digital Literacy and Skills;
- iii. Solid Infrastructure;
- iv. Service Infrastructure;
- v. Digital Economy Promotion and Development;
- vi. Soft Infrastructure;
- vii. Digital Society and Emerging Technologies; and
- viii. Indigenous Content Promotion and Development.
- 3.20 In his opening address, the Deputy Governor of Gombe State, Dr. Manasseh Daniel Jatau welcomed the Hon. Minister of Communications & Digital Economy, Dr. Isa Ali Ibrahim (Pantami), FNCS, FBCS, FIIM and other dignitaries to the 7th Meeting of the NCC&DE adding that the theme "Leveraging the gains of ICTs in developing and implementing a Digital Economy Strategy for Nigeria" was not only apt, but also timely considering the ongoing effort of the Federal Government towards the diversification of the Nigerian economy, with special focus on the ICT Sector which is the primary and most effective driver of economic growth and prosperity.
- 3.22 Giving the Vote of thanks, the Permanent Secretary Ministry of Communications & Digital Economy Mr. M.F. Istifanus thanked the Governor for hosting the event and the hospitality extended to participants since the beginning of the programme. He also thanked the Honourable Minister for his support which has made the hosting of the event possible. He thanked the Commissioners and participants for their robust discussions which he hoped would translate to policies that would move the sector forward.
